**Annual Town Board Meeting**  
**April 16th, 2024**

**Call to Order** – Chairman Paul Precour called the meeting to order at 6:00 PM at the Worcester Town Hall. Present were Supervisor Jim Michler; Supervisor Jeremy Pesko. Also present were Clerk/Treasurer Alli Mathys. There were 11 visitors.

**Approve minutes from April 18, 2023, Annual Town Board meeting** – Motion by Angela Michler, second by Jim Yanich to approve minutes from April 18, 2023, Annual Town Board meeting. Motion carried.

**Chair Report** – Chairman Paul Precour discusses getting things ready for work to begin for Disappearing Creek bridge, bids have been accepted and workers have been out removing trees. Next step is setting up a meeting with all the contractors and plan start date. Cannot start until after 6/15/2024 per the DNR. Also discussed starting the engineering process for Squaw Creek Bridge. We received part of the grant money for Chequamegon National Forest - \$89,000, and should receive the remaining balance soon. Also applied for a grant for Chequamegon National Forest for Popple Creek Rd and Wilson Lane, should hear back on April 23<sup>rd</sup>. Blacktop completed on Old 13. **Items for Discussion and Possible Action –**

**Public Input (Any & All Other Business Pertaining to the Township)** – Sylvia Kerner asks about Rock Oil and where the sales are documented on Financial Report. Explained it was marked under Sale of Recycled Materials. Sylvia Kerner also asks why we plow town roads with pick up truck, Chairman Paul explains that lack of snowfall meant the roads were soft, therefore plowing with a truck helps prevent any damage to roads. Steve Kerner mentioned that Bass Lake and Sandy Rd do not get soft, and to be careful during future plows. He also mentioned to look at Sandy Lane because it appears the center shoe from truck may have been dragging on road and caused damage. Sylvia Kerner also asks why some roads were left unplowed after snowfall; Neil confirmed all roads were plowed.
