

**ORDINANCE TO APPOINT TOWN ELECTOR TO THE
BOARD OF REVIEW
Ordinance 2024-12-6**

WHEREAS, pursuant to Wis. Stat. § 70.46(1), the Board of Review is made up of the Town Board Supervisors and the Town Clerk; and

WHEREAS, Wis. Stat. § 70.46(1m), prohibits appointed clerks, appointed treasurers, or appointed combined clerk/treasurers from serving on the Board of Review; and

WHEREAS, Wis. Stat. § 70.46(1m)(b), requires the Town Board to fill the vacancy created by the appointed position with an elector of the Town;

WHEREAS, the Town Board desires to have the person holding the office of appointed clerk serve on the Board of Review as a voting member, provided the person is an elector of the Town; and

WHEREAS, the Town Board desires that should the person holding the office of appointed Clerk not be an elector of the Town, that the Town Chair shall appoint an elector of the Town to fill that position on the Board of Review, subject to confirmation by the full Town Board.

Section 1: NOW THEREFORE, BE IT ORDAINED by the Town Board of Worcester, Price County, Wisconsin, as follows:

- (a) Appointed Town Clerk on Board of Review. The person holding the office of appointed Clerk is hereby appointed to serve on the Board of Review as a voting member, provided the person is an elector of the Town. Such appointment shall remain in effect until the person holding the office of appointed Clerk is no longer an elector of the Town or no longer the appointed Clerk, whichever occurs first.
- (b) Appointment if Clerk Is Not an Elector. If the person holding the office of appointed Clerk is not an elector of the Town, the Town Chair shall appoint an elector of the Town to fill the seat on the Board of Review, subject to confirmation by a majority of the remaining Town Board supervisors. Such appointment shall remain in effect until the person is no longer an elector of the Town, if the appointed Clerk becomes an elector of the Town, or if the person resigns. Further, the appointee may be removed by the Town Board at pleasure as set forth in Wis. Stat. § 17.13(1) or for cause as set forth in Wis. Stat. § 17.14(2).

Section 2: If any section, clause, provision, or portion of this Ordinance is adjudged unconstitutional or invalid by a Court of competent jurisdiction or by any agency or of any kind by anyone else, the remainder of this Ordinance shall not be affected.

Section 3: All Ordinances or parts of Ordinances in conflict herewith are hereby repealed.

Section 4: This Ordinance shall take effect and be in effect after passage and publication according to law.
